Mayor Cooper, Deputy-Mayor Lloyd and Members of Council:

I wanted to provide you with a brief email that will further outline our expectations of the Central Park Strategic Planning Session.

As noted in the Council Agenda , I will facilitate the workshop and begin by providing an outline of the goals and objective of the workshop. The session will then be turned over to Marta who will provide a detailed summary of what has been completed to date, the direction that staff has already been given and the issues that have recently come to light or are still outstanding. Marjory will then give a very brief look at funding options which will include, money already identified, the money from the Collus PowerStream partnership, funding opportunities and debenture costs. We were then hoping to provide each member of Council the opportunity to give their vision of the project, the size and scope of the project, what they see as the next steps, their idea on timing of the project, etc. In speaking with Mayor Cooper we were hoping to limit the individual Council presentations to 5 minutes but recognize that this may not be enough time to properly do so. If you have issue with this amount of time, please let us know prior to the Council Meeting and we will accommodate as best as possible. The most important part of this segment of the meeting is to allow each individual Council member the opportunity to be heard, uninterrupted and provide either their own personal opinion or that of a larger group. Once this portion of the meeting is complete Mayor Cooper and I will facilitate a discussion of all the views previously brought forward identifying common themes, issues, solutions and what are the potential next steps. At the end of the meeting we are hoping to arrive at a consensus on firm direction that staff can then work towards.

We are looking forward to openly and respectfully discuss this very important project. This project could easily be viewed as the single most important decision that any Council has made in many years. Please don't shoot the facilitator!
