Based on Dale's comments, and I think the direction that PRC and staff would like Council to consider would be a Direction A. Direction to staff to obtain the necessary drawings, etc... that will allow a phased construction based on the original design – and then we can get moving. I appreciate the concern with rescinding the endorsing in principle – but it was easier to provide a blanket resolution to reconsider matters that were previous decided. Instead we could word the motion like this:

"THAT Council reconsider previous direction with respect to the redevelopment of Central Park since 2011."

Direction B (Options 1 or 2- if constructed at Central Park) would basically be the same as a phased-in approach if Direction A is approved.

And if Council would like to cover the outdoor pool, we can consider that in addition to Direction A.

DIRECTION A

THAT Council endorse in principle, the recommended scenario for the redevelopment of Central Park

IN ADDITION, Council should consider the following:

AND FURTHER THAT Council direct staff to obtain architectural/engineering and site plan drawings that would include phasing options for consideration, with priority given to developing an additional ice surface.
